## **OPTIONAL: COMPANY PROFILE**

A company profile is optional and associated with basic company registration and company certification.

**Exception:** if you want to enter on full level certification and have  $\geq 5$  years experience  $+ \geq 75$  client assignments, the company certification is mandatory. You receive an exemption for documents PF.023 - 024.
